THE GRANT PROVIDES FINANCIAL ASSISTANCE TO ANIMAL WELFARE ORGANIZATIONS, AGENCIES AND INDIVIDUAL RESCUERS RESPONSIBLE FOR THE CARE OF ANIMALS RECOVERING FROM ABUSE, NEGLECT, AND INJURIES SUFFERED FROM A TRAUMATIC EVENT OR OTHER ILLNESS.
