EMERGENCY MEDICAL CARE GRANTS FOR ANIMALS PROGRAM - THE ISF EMERGENCY MEDICAL CARE GRANT FOR ANIMALS WAS ESTABLISHED IN FEBRUARY OF 2014. THE GRANT PROVIDES FINANCIAL ASSISTANCE TO ANIMAL WELFARE ORGANIZATIONS, AGENCIES AND INDIVIDUAL RESCUERS RESPONSIBLE FOR THE CARE OF ANIMALS RECOVERING FROM ABUSE, NEGLECT, AND INJURIES SUFFERED FROM A TRAUMATIC EVENT OR OTHER ILLNESS. THE PURPOSE OF THIS GRANT IS TO PROVIDE ANIMAL VICTIMS A SECOND CHANCE BY ALLEVIATING THEIR RESCUERS OF THE FINANCIAL STRESS OF TREATMENT, SO THEY CAN FOCUS ON FACILITATING THE ANIMAL'S ADOPTION INTO A PERMANENT, LOVING HOME. IN 2017, ISF GRANTED \$90,272 HELPING OVER 260 CREATURES, INCLUDING DOGS, CATS, HORSES AND OTHER
